# REQUEST FOR QUOTATION

Subject: Sale of Fly Ash and Pond Ash (in the Financial year 2022-23) by KSK Mahanadi Power Company Limited from its Thermal Power Plant located near Nariyara, Akaltara Tehsil, Janjgir-Champa District, Chhattisgarh

Last date for offer submission -5th April, 2022 by 17.00 Hours.

We are issuing this RFQ for the sale of Fly Ash & Pond Ash to be generated in the FY 2022-23 at KSK Mahanadi Power Company Limited Thermal Power Plant located near Nariyara, Akaltara Tehsil, Janjgir-Champa District, Chhattisgarh; the details of the requirements are as below:

## 1. Quantity in offer:

- a) The quantity in offer for selling Fly Ash and Pond Ash (in the FY 2022-23) by thermal power plant of KSK Mahanadi Power Company Limited (KMPCL) located at Village Nariyara, Akaltara Tehsil, Janjgir Champa District, Chhattisgarh is 25.00 Lacs MT and **6.00 Lacs MT** respectively.
- b) Minimum quantity to be quoted by the Buyer is 1000 MT.
- c) The Seller (KMPCL) shall:
  - issue the necessary gate pass for the Vehicles to be deployed by the Buyers i. to carry the Ash from the Plant.
  - Load the Bulkers/Hywas/Trailers from designated Silo loading point at the ii. plant (KMPCL).
  - allow the buyers to deploy loading Machine and Hywas/Trailers to load and iii. take Pond Ash in safe and environment friendly manners.
- d) The Buyers shall:
  - Take Fly Ash & Pond Ash through Road or Rail mode.
    - a) Make all necessary Environment friendly precaution to carry the Ash from Seller's plant to its End-use location.
  - b) deploy sufficient Bulkers/Hywas/Trailers at designated loading point inside the KMPCL premises. ahanaoch

cover all the Hywas/Trailers by Tarpaulin to avoid any spillage on transit.

Rake Pond Ash through road mode from Ash Dyke;

over all the Hywas/Trailers by Tarpaulin to avoid any spillage on transit.

- b) Make necessary arrangement for loading Hywas/Trailers from Ash Dyke by deploying sufficient Machinery.
- iii. For supply through rail mode;
  - a) inform Seller one day prior to raise indent for Rake loading.
  - b) shift the Fly Ash from Silo to designated place of Ash stock yard inside the KMPCL premises by deploying sufficient Hywas/Trailers.
  - c) load the rake in the stipulated time by deploying all necessary machinery.
  - d) cover the Wagons with Tarpaulin to avoid any spillage of Ash on transit.
  - e) Cover the shifted Ash by Tarpaulin all the time to avoid dust emission.

## 2. SELLING PERIOD

i. The selling period shall be valid for the period indicated in the Quotation by Buyer but shall not exceed 31<sup>st</sup> March, 2023.

#### 3. WEIGHMENT

- a) For disposal through road, the weighment done at KMPCL road weighbridge shall be final for billing purpose.
- b) For disposal through rail mode, weighment recorded at KMPCL in-motion weighbridge or any other weighbridge assigned by KMPCL to record the net weight of Ash disposed shall be final and binding for billing purpose.

### 4. QUOTATION

a) The buyers need to submit the following in their quotation and shall be applicable as given in the table below:

- b) All rates, sums and prices shall be stated in Indian rupees (INR.
- c) All taxes, Cess and Levies shall be applicable as per the relevant Indian Tax Acts, Rules and Regulations Applicable Taxes and Levies on and above the quoted Buying Price.

### 5. PAYMENT

a) Buyers shall deposit 100% of the applicable amount with Sellers for the Quantity to be lifting in one-week period. Seller shall issue the Invoice on weekly basis.

# 6. QUALIFICATION CRITERIA

- a) The Buyer shall be an Individual/partnership/company incorporated in India or and/or an Indian Citizen.
- b) The Buyer should have full knowledge of Ash Utilization Notification issued by MoEF & CC from time to time and shall abide by it.
- c) The bidder should not be a party to any legal case against KSK Mahanadi Power Company Limited or its officials or have instituted any case in any forum in India against KSK Mahanadi Power Company Limited prior to the date of this RFQ.

### 7. ARBITRATION

- a) Any dispute, controversy or claim arising out of or relating to this RFQ, or the breach, termination or invalidity thereof shall be settled by reference of dispute to sole arbitrator to be appointed on mutual discussion.
- b) The arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996. The place of arbitration shall be Hyderabad, Telangana. The language used in arbitral proceedings shall be English.
- c) The award rendered by the sole arbitrator shall be final and binding on the Parties.

### 8. JURISDICTION:

 All the disputes and differences arising under or out of or in connection with the purchase order shall be subject to the exclusive jurisdiction of the Courts of Hyderabad.
