Expression of Interest (EOI)

Subject: Free-of-Cost supply of Fly Ash and Pond Ash (in the Financial year 2022-23) on the basis of First-cum-first-serve by KSK Mahanadi Power Company Limited from its Thermal Power Plant located near Nariyara, Akaltara Tehsil, Janjgir-Champa District, Chhattisgarh.

Last date for offer submission -12th April, 2022 by 17.00 Hours.

We are issuing this EOI for Free-of-cost supply of Fly Ash & Pond Ash on the basis of 'Firstcum-first-serve' to be generated in the FY 2022-23 at KSK Mahanadi Power Company Limited Thermal Power Plant located near Nariyara, Akaltara Tehsil, Janjgir-Champa District, Chhattisgarh; the details of the requirements are as below:

1. Quantity in offer:

- a) The quantity in offer for Free-of-cost supply of Fly Ash and Pond Ash (in the FY 2022-23) on the basis of 'First-cum-first-serve' by thermal power plant of KSK Mahanadi Power Company Limited (KMPCL) located at Village Nariyara, Akaltara Tehsil, Janjgir Champa District, Chhattisgarh is 25.00 Lacs MT and 6.00 Lacs MT respectively.
- b) Minimum quantity to be quoted by the Interested party(s) is 1000 MT.
- c) The Supplier (KMPCL) shall:
 - Supply Fly Ash for Free-of-cost on First-cum-first-serve basis from the designated loading point of Silo.
 - ii. Supply Pond Ash for Free-of-cost on First-cum-first-serve basis but loading arraignment shall be under the scope of Interested Party(s).
 - iii. issue the necessary gate pass for the Vehicles to be deployed by the interested Party(s) to carry the Ash from the Plant.
 - Ìν. Load the Bulkers/Hywas/Trailers from designated Silo loading point at the plant (KMPCL).
 - allow the Interested party(s) to deploy loading Machine and Hywas/Trailers to load and take Pond Ash in safe and environment friendly manners Mahanan
- d) The Interest Party(s) shall:
 - Take Fly Ash through Road mode.

- a) Make all necessary Environment friendly precaution to carry the Ash from Supplier's plant to its End-use location.
- b) deploy sufficient Bulkers/Hywas/Trailers at designated loading point inside the KMPCL premises at their own cost.
- c) cover all the Hywas/Trailers by Tarpaulin to avoid any spillage on transit.
- ii. Take Pond Ash through road mode from Ash Dyke;
 - a) Make all the arrangement for loading the Pond Ash by deploying necessary loading machines at their own cost.
 - b) cover all the Hywas/Trailers by Tarpaulin to avoid any spillage on transit.
 - c) Make necessary arrangement for loading Hywas/Trailers from Ash Dyke by deploying sufficient Machinery at their own cost.
- iii. For supply through rail mode;
 - a) Make all the arrangement for shifting of Fly Ash from Silo, stacking and loading into the wagon at their own cost.
 - b) inform Supplier one day prior to raise indent for Rake loading.
 - c) shift the Fly Ash from Silo to designated place of Ash stock yard inside the KMPCL premises by deploying sufficient Hywas/Trailers.
 - d) load the rake in the stipulated time by deploying all necessary machinery.
 - e) cover the Wagons with Tarpaulin to avoid any spillage of Ash on transit.
 - f) Cover the shifted Ash by Tarpaulin all the time to avoid dust emission.

2. SELLING PERIOD

i. The supplying period shall be valid for the period indicated in the Quotation by the Interested Party(s) but shall not exceed 31st March, 2023.

3. WEIGHMENT

- a) For disposal through road, the weighment done at KMPCL road weighbridge shall be final for supplying purpose.
- b) For disposal through rail mode, weighment recorded at KMPCL in-motion weighbridge or any other weighbridge assigned by KMPCL to record the net weight of Ash disposed shall be final and binding for supplying purpose.

4. QUOTATION

a) The Interested Party(s) need to submit the following in their quotation as given in the table below:

b) All taxes, Cess and Levies shall be applicable as per the relevant Indian Tax Acts, Rules and Regulations Applicable Taxes and Levies on and above the quantity.

5. QUALIFICATION CRITERIA

- a) The Interest Party(s) shall be an Individual/partnership/company incorporated in India or and/or an Indian Citizen.
- b) The Interest Party(s) should have full knowledge of Ash Utilization Notification issued by MoEF & CC from time to time and shall abide by it.
- c) The Interest Party(s) should not be a party to any legal case against KSK Mahanadi Power Company Limited or its officials or have instituted any case in any forum in India against KSK Mahanadi Power Company Limited prior to the date of this RFQ.

6. ARBITRATION

- a) Any dispute, controversy or claim arising out of or relating to this EOI, or the breach, termination or invalidity thereof shall be settled by reference of dispute to sole arbitrator to be appointed on mutual discussion.
- b) The arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996. The place of arbitration shall be Hyderabad, Telangana. The language used in arbitral proceedings shall be English.
- c) The award rendered by the sole arbitrator shall be final and binding on the Parties.

7. JURISDICTION:

a) All the disputes and differences arising under or out of or in connection with the Supply order shall be subject to the exclusive jurisdiction of the Courts of Hyderabad.
